TECHNOLOGY CORNER

'Using the Marshall & Swift / Boeckh Residential Estimator'

I'm sure a lot of you are using the Marshall & Swift / Boeckh Residential Estimator. I've been using it since about May of 2003. I must admit I did not like it at first, especially when I found out there was no conversion of the data from the old Boeckh program to this one. All the data would need to be re-entered. After a few sessions with some very good instructors I was comfortable using this new tool. Below are a few tips that I have found useful.

Q. Can I delete multiple records from my database?

A. From the main screen click "File | Delete/Archive" or use the shortcut "Control + D". This will open an empty browse window, but if you click the "Find Now" button the browse will fill with all your records. The trick to marking multiple records is to press the Control key while left clicking the mouse on the left side of the records you want marked (the column that has the right arrow in it).. Now you can click the "Delete" button and a screen will appear asking if you want to "delete only" or "delete and archive" which will put the deleted records into an archive file that can be saved and restored if need be.

Q. If I enter the base square footage for a two story dwelling will the program figure it right?

A. Unless you entered 2 times the base square footage for a two story dwelling you will not get the correct rebuilding calculation. For a 1 $\frac{1}{2}$ story dwelling you need to multiply the base square footage by 1.5 and for a two story dwelling multiply by 2. The program will enter the correct square footage for you if you use the "Len x Width" button and enter the proper length and width of the dwelling.

Q. How come the rebuilding cost is so high when I enter a dwelling built prior to 1940?

A. The pre-1940 settings will calculate rebuilding using full 2x4's and lathe and horsehair plaster which more than likely will not be using to rebuild after a loss. You may want to consider changing the construction to "Standard" for these dwellings.

Q. How do I adjust for a Bi-Level home that is not finished on the lower level?

A. A Bi-Level home is considered two full levels of living area. Since the lower level accounts for 50% of the total living area, and is not finished, go to the "Interior" tab and enter 50% totals for the Partitions, Wall Coverings, Ceiling and Flooring. This will adjust the rebuilding total for the first label.
