TECHNOLOGY CORNER

"A Systems Vender!"

Recently we consulted with a medium size mutual insurance customer of ours on the purchase of hardware from a third party. We attempted to focus them on what we perceive to be the real issue:

You are not just purchasing hardware. You are "hiring" a systems vendor. Your systems vendor will be the person responsible for the installation, configuration, security, and upgrades of all hardware and software in your office.

Many companies wish to use the Mutual Insurance software provider as their hardware provider and thus to be their system vendor. The theory is "one-stop support". One of the secondary risks in "hiring" an outside system vendor is getting caught between the system vendor and the software vendor on a critical issue. It does happen, it's very rare, but it can be very painful for ALL involved. The frequency is very low, but when it happens, the discomfort may be very high.

The mutual provided us with the hardware information on the proposals of two system vendors. True to form, one proposal was very professional looking, quoting mostly HP hardware, with pretty much everything they needed. (Hewlett-Packard, aka HP, is one of the top tier vendors providing quality hardware.) The other proposal was less professional with "no-name" hardware, missing certain key elements. The professional system vendor had dedicated system software staff in house to assist with those type of issues, the less professional system vendor was more or less a single person operation. You can guess who had the lower price. In the best interest of the customer, after weighing all the factors involved, we recommended the more professional system vendor. Even though price is always a factor, we felt it was not the main factor in making the decision. The company followed our recommendations and purchased from the professional system vendor.

In the end, it is better for all if the mutual insurance software provider has an opportunity to review the proposal. In all cases the software provider has more knowledge and experience on what is needed than an individual mutual manager.

It's a bit early to reach conclusions on the long term benefits of the purchase, but the short term had a few understandable glitches, but over all has been successful.

The decision on a system vendor is a long term decision. In all likelihood, you will live with it for the lifetime of the equipment installed. It is possible that some other vendor would be willing and able to provide support, but they are pretty rare. Good system vendors seem to survive, bad system vendors disappear pretty quickly. Make your decision cautiously, and make it wisely.
