#### February 2020 Board Meeting Synopsis Greg Parent, Secretary-Treasurer



The MAFMIC Board of Directors held their annual financial review and board orientation meeting at the Radisson Blu Hotel in Bloomington on Sunday, February 9 during the convention. The primary focus of this meeting each year is to review and approve the financial statements from the previous year for distribution to the membership at the Annual Business Meeting. Secretary - Treasurer, Greg Parent presented the 2019 financial statements. The board discussed several items and approved the financial report as presented. The financial report was then given to the membership at the Annual Meeting on Tuesday, February 11.

Chairman Mark Nelson recognized the retiring board members, Roger Miller of Lake Park & Cuba Insurance, Eric Johnson of Woodland Mutual and Immediate Past-Chairman Mikel Nelson of Elmdale Mutual. Chairman Nelson also welcomed the new incoming board members, Angela Campbell of Chisago Lakes Mutual and Laurie Wellnitz of Agassiz & Odessa Mutual. Chairman Nelson then recognized the new Vice Chairman Larry Johnson of North Star Mutual and set to begin his twelfth term as Secretary-Treasurer, Greg Parent of German Farmers Mutual. The new board members officially assumed their positions at the Annual Meeting on February 11 while the Vice Chairman and Secretary-Treasurer were elected to their positions.

Chairman-Elect Dan Rupp announced the Committee Chairman assignments for 2020. Since all current committees had at least one board member on them and they could report on committee activity, there was no need to assign any board committee liaisons. Chairman Nelson reported that, assuming the Bylaws change passes at the Annual Business Meeting, he had appointed Roger Miller as Chairman of the MAFMIC Scholarship Committee.

Event Coordinator/Office Manager Dani Hennen updated the board on the corrected HSA amount on the 2020 budget and indicated that MAFMIC chose Verizon Wireless as their cell phone provider. President/CEO Adam Axvig updated the board on the MAFMIC vehicle and Sentry Bank credit cards. Adam also handed out a document from the State of Minnesota showing the gift ban guidelines for politicians. Chairman Nelson provided an update on the staff meal allowance that he and Dan Rupp had visited with Adam Axvig about.

The board approved 2 trees Valuation, Somerset Reinsurance Brokers and Associated Bank as new Associate Members. The board also approved to direct the net proceeds from the MAFMIC Golf Outing to the Scholarship Fund for 2020.

The next scheduled board meeting will take place in Spicer on June 17-18. The auditor for

MAFMIC, Matt Taubert, will review his annual audit report at the June board meeting. Members are encouraged to contact their MAFMIC District Director with any concerns or issues that may need to come before the board.



#### "Prepare for spring storms before they strike" Dan McCue, Grinnell Re, AINS, Digital Marketing Strategist

April showers can certainly bring May flowers, but they also bring wind, hail, lightning, and floods — weather events that can do a lot of damage to property.

Minnesota Severe Weather Awareness Week is April 13–17, so we've put together a list of some simple things you can do to prepare your home for spring storms.

#### **Inspect your home**

**Check your roof**. Roofs are particularly susceptible to high winds and tornadoes. Do an inspection, looking for loose siding and roofing materials — especially shingles and metal panels. These may blow off easily and take other materials along with them.

Make sure you have surge protection. A lightning strike or power outage could fry your expensive devices.

**Keep up with tree-trimming**. Dead branches can cause a lot of damage when they land on your house or your car.

**Clean out your gutters**. If they're plugged up, the water will find somewhere else to go — like your basement, between the siding and exterior walls, or through leaky windows.

**Test your sump pump**. If it's not working, it won't do you much good if water does end in your basement.

**Batten down the hatches**. If you know bad weather is coming, put away or secure any outdoor furniture, toys, bikes, and other loose objects.

#### Pack your emergency kit

Packing emergency kits for your home and your car will prepare you for severe weather. <u>Ready.gov</u> recommends including the following items in your kit.

Flashlights and extra batteries.

First aid kit that includes necessary medications. Include formula and diapers if you have small children.

**Non-perishable food.** Include protein-rich foods such as nuts, energy bars, and canned foods. Pack a manual can opener, too.

Water is even more important than food. Pack at least 1 gallon of water per person per day.

**Basic tools** including pliers, a wrench, and screwdrivers.

**Radio**, either battery-powered or hand-cranked. **Clothes** including gloves, hat, and rain poncho. You may also want a change of clothes for each member of your family.

Blankets or sleeping bags.

**Cell phone chargers** that can be used in the wall or in your car.

**Pet supplies** for your pet, including food and water. **Cat litter** for better tire traction.

Jumper cables for your vehicle.


#### "Multi-Factor Authentication: Why You Should Always Opt In" Joel Peiffer, IMT Computer Services

Too often we hear about accounts and passwords being compromised by hackers. What is more troubling are the tools and methods they use to obtain a user's credentials are only growing and becoming more efficient. In a previous article we discussed the benefits of using password managers that help generate strong, unique passwords to help minimize your password redundancy and susceptibility. Depending on the account, you may be able to add a second layer of protection by enabling Multi-Factor Authentication (MFA).

MFA is the single most effective thing you can do to protect yourself from a phishing attack. It is a two-step method by which an account will only grant access to a user attempting to log in after they have provided two forms of verification. The first piece would be something you know. Most often times this would be your unique account password. The second form of identification would then be something you have. Something you have could be a: security key, code generated by an authenticator application, push notification, or unique code sent to you by email or text message. So even if your password itself was compromised, a hacker could not access your account unless they also had your second factor of authentication.

Security keys can be used by inserting them into your device's USB port or connected by Bluetooth. You register your key the first time it is used so your account will only be unlocked when triggered by that specific key. Studies show using a security key is the most effective and secure second form of identification for MFA. Several brands of security keys to consider are: Yubico, Google Titan or Thetis. Similar to a security key, with an authenticator application you must first link it to your account. Once you enter your password you are then prompted to enter your pin generated by the app on your phone. Every 60 seconds the sequence is changed, which makes it more difficult to steal a pin by an outside source. Some well-known authenticating apps are: LastPass Authenticator, Microsoft Authenticator, Google Authenticator or Duo.

MFA doesn't completely eliminate the chance of an issue arising, but it is the most effective way to minimize your risk. Not all accounts offer MFA at this time, but it is becoming increasingly available. I encourage all of you to look in to your online accounts and see which ones offer MFA and enable this feature for all your online services, especially: email, Facebook, banks, and other sensitive web services. While there are people who read this and cringe at the thought of having to use a second form of identification, consider this. Would you rather take an additional small step (probably around 5-10 seconds) when signing in to an account, or spend hours on the phone trying to lock down your credit cards, cancel subscriptions, or run the risk of losing your identity once your account has been compromised?
